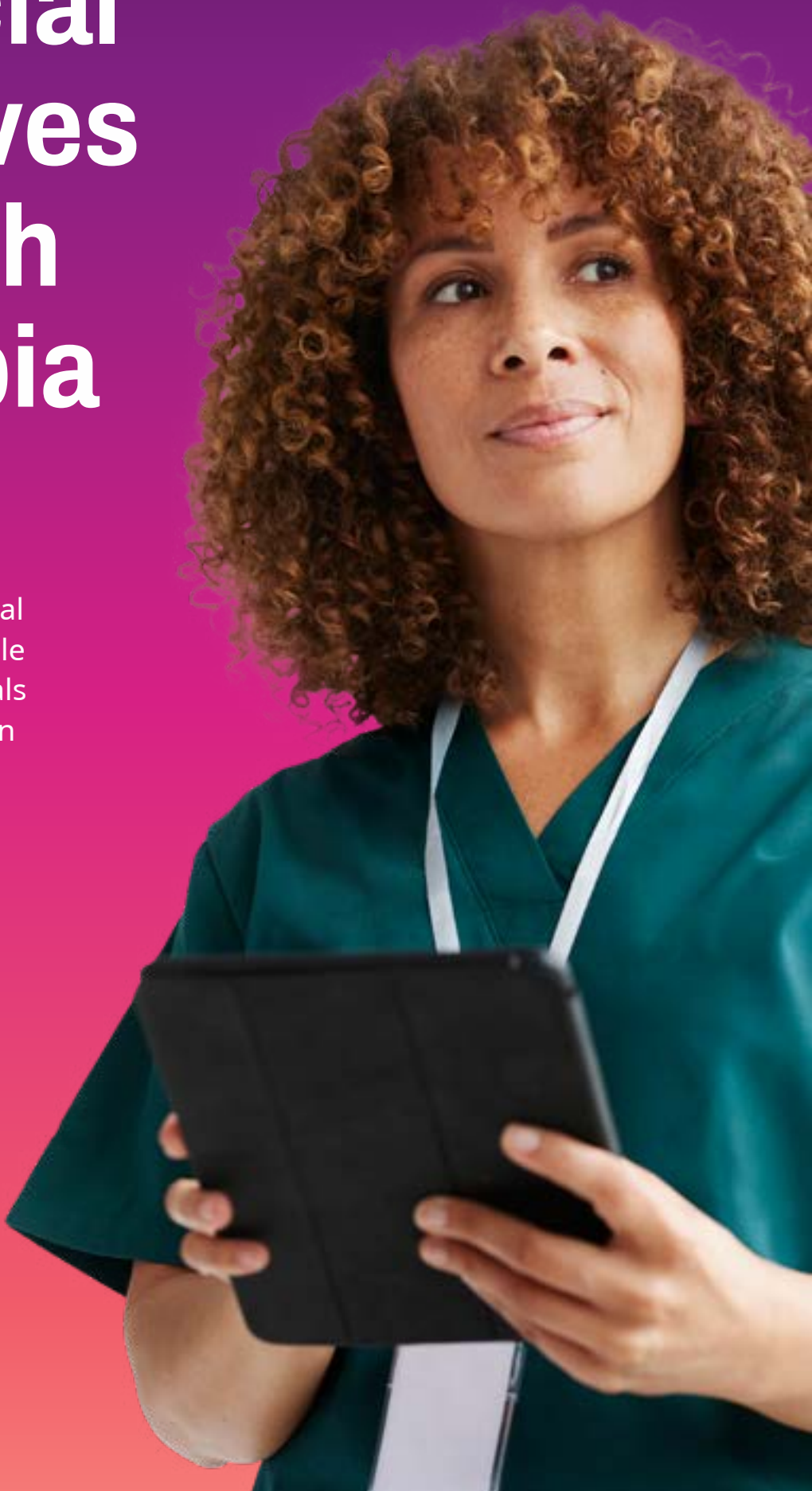


Provincial Incentives in British Columbia

British Columbia has several financial incentives available for health care professionals wanting to work and stay in B.C.



Provincial Rural Retention Incentive (PRRI)

If you accept a position in an eligible rural or remote community, you could receive PRRI incentive of up to \$2,000 every quarter, to a maximum of \$8,000/year.

- This incentive is pro-rated to hours worked for healthcare workers in 74 communities across B.C. – view them [here](#).
- Regular (not casual) healthcare workers employed by a health authority in the listed 74 communities are eligible for PRRI. Connect with your prospective employer to confirm your eligibility.
- This program runs from April 1, 2024, until March 31, 2025.

GoHealth BC Recruitment and Retention Incentive

[GoHealth BC](#) is B.C.'s provincial travel nursing program, which allows staff to travel and see the province while working directly for the public health-care sector. GoHealth BC ensures that staff have the flexibility to select their schedules and shifts, while maintaining the benefits and security of working for a health authority.

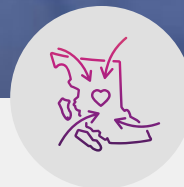
- Eligible staff who join GoHealth BC between April 1, 2024 and March 31, 2025 will receive a signing bonus of up to \$10,000 with a 12 month return of service.
- If you work 1,500 hours within a 12-month period, you'll also be eligible for an additional retention incentive of up to \$5,000.

Rural and Remote Recruitment Incentive

B.C.'s rural and remote communities provide access to nature and recreational opportunities around the province. Whether you're a skier, hiker, surfer, or cyclist, there's a community that'll fit your lifestyle. Between April 1, 2024, and March 31, 2025:

- Eligible positions that fill high needs vacancies in Northern Health will receive signing bonuses of up to \$30,000.
- Eligible positions that fill high needs vacancies in other rural and remote communities across the province will be eligible for up to \$20,000.

These incentives are pro-rated to FTE and come with a 24-month return of service.





Recruitment Incentive for Difficult to Fill Vacancies (Urban and Metropolitan)

If you want to access all B.C. has to offer in an urban or metropolitan region you could still be eligible for a signing bonus if you take a position that fills a high-needs or difficult to fill vacancy. Between April 1, 2024, and March 31, 2025:

- Eligible positions that fill high needs vacancies in urban areas will receive a signing bonus of up to \$15,000.
- This incentive is pro-rated to FTE and comes with a 24-month return of service.

The above information is only an overview of the exciting incentives available to individuals starting careers in B.C.'s public health sector. Be sure to consult with HealthMatchBC or your prospective employer (eg. GoHealth, Interior Health, etc) to verify your eligibility and details.

- We have several signing bonuses to make your transition to working in B.C. easier. Though you may be eligible for multiple incentives, the maximum you can receive is \$30,000.
- Eligibility is dependent on multiple factors including position, employer, occupation, and community. For more information, contact HealthMatchBC or your prospective employer directly.
